** A smaller initial gift may be considered if the donor sufficiently demonstrates that the fund will reach the minimum value through added gifts by an agreed upon deadline. Fees are assessed at 2% at maturity.

1. A two (2) year spend-out on non-endowed funds applies unless otherwise agreed.

2. Fiduciary conduit services. BCF may act as a fiscal sponsor to any recognised, Bermuda-based charity or nonprofit programme. BCF's gift and grant policies apply. A maximum transaction limit may apply.

3. BCF's fees on funds cover the cost of services related to fund administration, client intake and a one-hour annual consultation. Additional advisory services and products, including presentations and speaking engagements, may be made available for a fee on a case-by-case basis.

4. Emerging philanthropist agreement. See policy.

5. No payout until the Fund's principal reaches \$50,000, excluding promotions and special waivers.

6. BCF will advise on available giving/fund options for contribution amounts below the standard minimums and on other legacy giving options.
