### CONTRIBUTION PAYMENT METHODS

#### 1. International Wire Transfer

International wire transfers may require you to input correspondent or intermediary bank details. This information can be found below. **However, please ensure that HSBC Bank of Bermuda, Hamilton is noted as the beneficiary bank.** If you list the intermediary bank as the beneficiary, the transaction may fail, and the funds will be returned to you.
